

# Tech Moment

In August we discussed LinkedIn and Facebook. LinkedIn is used more for networking with other professionals, and Facebook is social media more commonly used for family, friends, and acquaintances. Both require you to set up an account before you can see what others post, allow you to share comments, pictures, or videos with others, and can be accessed using a computer, smart phone, or tablet. To set up an account you can go to www.facebook.com (for Facebook) and www.linkedin.com (for LinkedIn). There is some required information for each registration, however, you have some control over what information you choose to provide and with whom that information is shared.

October's Tech moment very briefly discussed cloud storage services. There are many options for cloud storage that vary in amount of storage, file size restrictions, and cost (several offer some free storage). Using cloud storage services allows access to your files anywhere you have internet access, even if you do not have your personal computer/phone/tablet, and most allow you options to share documents and files with other people that you invite; depending on how you share, they can see a "read only" copy or be able to edit it.
